1. Vehicle Entry Fee.

To Considered imposition vehicle entry fee in the Fatehgarh Cantt. Board after implementation of GST from 01-07-2017. The Board shall consider advice of CBLA & CA of this Board. Presently vehicle entry fee has been suspended.

Resolution No. 1 :- The Board understands that there is no clear clarity on the issue of Vehicle Entry Fee after implementation of GST. The advice of the CA and Legal Opinion taken by the Board shows that Vehicle Entry Fee is not a Tax and may be exempted under GST. The Vehicle Entry Fee should not be removed but may be kept suspended till full clarity is obtained from the Deptt or the Govt. of India.

The issue of the loss to the contractor will have to be considered when the final decision is taken.
